- **Community transparency for Smart Flow of funds where a portion of revenue is used to purchase rewards from the market to be placed in a fund to support decentralized operations, the DGF, Connect Events, and other community initiatives.**
- **All purchases through Connect will be paid out in the native blockchain rewards associated with the product purchased beginning 11/26/24.**
